No contract may be made between the sub-contractor and the employer (employer's supervision) related to the performance of work under this sub-contract. If the sub-contractor receives any message or instruction from the employer (employer's supervision), the sub-contractor must immediately submit the message or instruction received to the main contractor.</p> <p>The main contractor undertakes to keep the sub-contractor regularly informed of all agreements between the main contractor and other sub-contractors and of all agreements between the main contractor and the employer and all instructions from the employer (employer's supervision), which may be of importance to the sub-contractor's work by e.g. sending minutes from site meetings.</p>
